Members of the Middlesex Detachment of the Ontario Provincial Police (OPP), along with the London Police Service, London-Middlesex Paramedic Services, and the London Fire Department, responded to a single-vehicle collision on Highway 401 westbound, west of Veterans Memo-

rial Parkway, in the City of London. At approximately 9:40 a.m., emergency services were called to the scene involving a school bus carrying 42 passengers, including secondary school-aged students. The bus left the roadway, resulting in a single-vehicle collision. Four passengers were transported to a local hospital with minor injuries. The driver of the bus, a 52-year-old male from the Waterloo Region, was pronounced deceased at the scene.


THEFT OF ALCOHOL FROM **BUSINESS IN** MIDDLESEX CENTRE

The accused has been released from police custody and is scheduled to appear in the Ontario Court of Justice in London on December 1, 2025, to speak to the charges.

TWO-VEHICLE COLLISION SENDS THREE INDIVIDUALS TO **HOSPITAL**

NORTH MIDDLESEX, ON) - A two-vehicle collision sent three individuals to hospital with non-lifethreatening injuries. On October 16, 2025, at 11:30 a.m., members of the Middlesex County Ontario Provincial Police (OPP), Middlesex-London Paramedic Service, and North Middlesex fire, were dispatched to the intersection of Nairn and Centre Roads, North Middlesex for the report of a serious two-vehicle collision between two Sport Utility Vehicles (SUV). Three individuals were transported to hospital with non-life-threatening injuries. As a result of the collision, one SUV rolled into a field and the second SUV caught fire within the intersection. The intersection was closed for approximately six hours as police investigated and has since opened.
